STEPS IN THE WORLD WRAPPS FRANCHISING PROCESS

Step 1. Complete and submit the Franchise Application.

- Step 2.** Following receipt and review of your completed application, a Uniform Franchise Offering Circular (UFOC) will be mailed to you as required by law, unless either party terminates the application process at that time.
- Step 3.** You will be contacted by World Wrapps corporate office to schedule an interview.
- Step 4.** An outside credit company will complete a background search and credit report on you and your spouse to verify all information.
- Step 5.** If your initial interview and your financial review are satisfactory, you will be invited to have a “World Wrapps Day” at our corporate offices, where you will meet and talk with the head of each department. You will also be invited to visit as many World Wrapps restaurants as possible, and to talk with other franchisees, store managers and customers as part of your due diligence investigation.
- Step 6.** If you are approved and wish to proceed, we will enter into a Development Agreement with you, and you will pay the associated fees.
- Step 7.** You will receive a letter stating that you have 120 days to submit a site.
- Step 8.** World Wrapps will review the proposed site, and also view other sites you are considering.
- Step 9.** You will enter into a lease for the proposed site, after the lease has been reviewed by World Wrapps, subject to finalizing your financing.
- Step 10.** You will finalize your own financing arrangements.
- Step 11.** Construction and training will begin.
